Due to differences in computer monitors, your images may appear lighter, darker, off-color or even unsharp. Do not be concerned, as they will be printed to our exacting standards and carry our 100% Guarantee to you (see below).

Your images will only be online for <u>30 days</u>, if you need them extended for another 30 days just let us know but be aware there is a **25.00** fee for doing so. To give you the best quality images and avoid errors we always ask you to come to our studio to place your order. If you place your order within <u>two weeks</u> of receipt of this email you will receive a CD of low-resolution images from every print you order from us. If you choose the "Backyard" (Session Option #1) and have not placed your order within <u>60 days</u> after the images were first posted online you will forfeit your entire **8"** x10" **Print Credit**. If you choose one of the "On-Location" (Session Option #2) and have not placed your order within <u>60 days</u> after the images were first posted online you will begin to forfeit **25.00** of your minimum order deposit <u>every month</u> thereafter.


- 1. All images include basic retouching on things like minor blemishes and hairs out of place. Braces, excessive acne or something more involved can be done but will need to be determined at time of order.
- 2. Any image may be cropped. A full length image can become a head shot. Cropping allows for the subject to be more prominent and is advisable for wallet images. There is NO additional charge for this.
- 3. Sometimes images have been given a special effect on them. These are copies of the master image and usually have a -2 (dash two) after the number. There is NO additional charge for these altered images or if you want that effect put on a different image.
- 4. You may also get your images in Sepia, or Black & White just let us know when you place your order and there is NO additional charge.
- 5. We highly recommend you make use of the feature to create your *Favorites*. Everyone may create their own set, which is helpful for considering multiple opinions.
- 6. Feel free to give your password to anyone you would like to view your gallery. All images are also available for friends and family to order directly with us, so if you want this feature added please just let us know. Note that we can not accept orders from you, the client, in this way.
